ILLINOIS, HELD ON THE 22nd of AUGUST, 2016, AT 6:30 P.M. IN THE PINCKNEYVILLE
COMMUNITY HIGH SCHOOL BUILDING IN THE PINCKNEYVILLE SCHOOL
DISTRICT.

The Board of Education of Pinckneyville Community High School District #101, Perry County, Illinois, met in a regular session on the 22nd of August, 2016, at 6:30 p.m. at the Pinckneyville Community High School in that district. The following officers and members of the Board were present: Greg Thompson, President; Lisa Stanton, Secretary; Brian Kellerman, Jennifer Robb, Kyle Pursell, Paul Kuberski. and Greg Bigham. Keith Hagene, Superintendent, Penny Corn, recording secretary, and Dustin Foutch, Principal, were also present.

Visitors were invited to address the Board. Coach Bob Waggoner read a letter on behalf of the PCHS coaching staff opposing the soccer club co-op which was approved last month. Bill Block also spoke in opposition to the soccer club.

Mr. Foutch reported that the beginning of the school year has been smooth. He also stated that we received PARCC scores from last year's tests and our students scored approximately 18% higher in math than the state average, and 10% higher in English. We had 60 freshmen participate in the Math Academy held a few weeks prior to the beginning of the school year, which is over half of the class. Mr. Foutch praised the program and thanked Mr. Heckert and Ms. Wilson for their dedication to PCHS.

Mr. Waggoner gave a report on the summer training programs and fall sports which are beginning this week. He reported that fall sports numbers are competitive but not as many as would be preferred.

Mr. Hagene reported that the new classroom clocks have arrived and are ready for installation. We should receive the refurbished laptops soon. He gave an update of budget information, and reported that he had received one FOIA request this month.

Mr. Hagene reviewed Educational Support Personnel Policy Updates.
