

MINUTES OF SPECIAL MEETING OF THE BOARD OF EDUCATION OF  
PINCKNEYVILLE COMMUNITY HIGH SCHOOL DISTRICT #101, PERRY COUNTY,  
ILLINOIS, HELD ON THE 6th OF MAY, 2013, AT 6:00 P.M. IN THE PINCKNEYVILLE  
COMMUNITY HIGH SCHOOL BUILDING IN THE PINCKNEYVILLE SCHOOL  
DISTRICT.

The Board of Education of Pinckneyville Community High School District #101, Perry County, Illinois, met in a special session on the 6th of May, 2013, at 6:00 p.m. at the Pinckneyville Community High School in that district. The following officers and members of the Board were present: Nathan Kellerman, President; Brian Kellerman, Secretary; Michelle Breslin, Larry Hardin, Greg Bigham, and Dawn Kellerman-Smith. Keith Hagene, Superintendent, Dustin Foutch, Principal, and Penny Corn, recording secretary, were also present.

It was moved by Michelle Breslin and seconded by Dawn Kellerman-Smith to approve the minutes of the previous meeting as presented. The current Board was declared dissolved by Nathan Kellerman.

Nathan Kellerman opened the floor for nominations for the office of President. There were no other nominations. Dawn Kellerman-Smith was seated as Board President by a unanimous vote and conducted the remainder of the meeting.

Dawn Kellerman-Smith opened the floor for the office of Vice-President. Paul Kuberski nominated Greg Thompson. There were no other nominations. Members voted unanimously in favor.
