The Board of Education of Pinckneyville Community High School District #101, Perry County, Illinois, met in a regular session on the 22nd of February, 2016, at 6:30 p.m. at the Pinckneyville Community High School in that district. Mr. Foutch presented the IDTA State Champion PCHS Pompon Squad. He and Mr. Cannedy commended the group for being talented and extremely hard working young women who met challenges throughout their season and triumphed by winning first in State with their Jazz routine.

He then recognized the FCCLA club by introducing Kara Lacy, Kayce Morgan, and Rachel Loos. These girls had prepared a presentation explaining some of the community service projects this very active club is involved with. They recently had an extremely successful toy drive for the Perry/Jackson Advocacy Center with over 500 toys donated by PCHS students.
