

MINUTES OF REGULAR MEETING OF THE BOARD OF EDUCATION OF  
PINCKNEYVILLE COMMUNITY HIGH SCHOOL DISTRICT #101, PERRY COUNTY,  
ILLINOIS, HELD ON THE 27th of FEBRUARY, 2017, AT 6:30 P.M. IN THE  
PINCKNEYVILLE COMMUNITY HIGH SCHOOL BUILDING IN THE PINCKNEYVILLE  
SCHOOL DISTRICT.

The Board of Education of Pinckneyville Community High School District #101, Perry County, Illinois, met in a regular session on the 27th of February, 2017, at 6:30 p.m. at the Pinckneyville Community High School in that district. Keith Hagene, Superintendent, Penny Corn, recording secretary, and Dustin Foutch, Principal, were also present.

Mr. Foutch introduced the Board to Austin McAllister, our newly hired Ag teacher. Mr. McAllister spoke very passionately about his excitement to have the opportunity to resurrect the Agriculture program at PCHS.

Mr. Hagene informed the board that DuQuoin's Board of Education voted against the proposed Soccer Co-Op between our two schools. At this time no action was taken concerning soccer.
